

Mayor Warns of Possible SMRR Takeover

MRR's platform is clear: Protect renters, create more affordable housing, and don't sacrifice quality of life to unneeded over-development. With the adoption of a new renter-protective slowgrowth zoning code that is progressive without being excessive, the SMRR City Council majority has certainly been there for you this year.

Now we must ask you to take some time on November 1st to be there for us.

As an open, democratic organization, SMRR is subject to hostile takeover by those who feel they can't win control of our city any other way. They know that if they can hijack the SMRR name behind the scenes in this off-year, they have a better chance of electing their own Council candidates next year.

SMRR's continuing and consistent success has encouraged these efforts, and we can't let SMRR's achievements lull our historic membership into complacency. We need you on November 1st.

What if SMRR stopped making renter protection a priority? There are those who actively oppose affordable housing – what if they took over SMRR? What if SMRR became a front for progrowth interests, favoring developer profits over neighborhoods? Are you willing to risk any of that?

Last year, outside interests were so prevalent at the SMRR endorsement convention that our ability to support Council candidates was stolen from us. Special interest bullet voting fragmented our organization.

This fulfilling and satisfying year as your Mayor has been almost enough to make me forget that in 2014 no one, including me, was able to achieve the City Council endorsement threshold at our SMRR convention. There were too many competing factions beholden to their own agendas, not to the SMRR platform.

I'm grateful for your support, and for being elected to a fifth term as a SMRR Councilmember, but we can't afford to cede control of SMRR to those who don't have our renter, housing, and quality of life interests at heart. The best defense against a hostile takeover is reenergized participation by our long-time base – you.
